

MINUTES OF THE REGULAR SESSION OF THE LINN COUNTY BOARD OF COMMISSIONERS TUESDAY MEETING LINN COUNTY COURTHOUSE – ROOM 200 MARCH 22, 2022

The Linn County Board of Commissioners met for the regularly scheduled meeting on Tuesday, March 22, 2022.

1, 2, 3. At 9:30 a.m. Chair Nyquist called the meeting to order. The flag salute and roll call followed. Commissioners Roger Nyquist, Chair; Will Tucker, Vice-Chair and Commissioner Sherrie Sprenger were present, as well as, Darrin L. Lane, Linn County Administrative Officer and Marsha Meyer, Recorder for the Board of Commissioners.

4. Approval of Agenda.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve the agenda. The vote was called. The motion passed unanimously.

5. Approval of the March 15, 2022 Commissioners' Meeting Minutes.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve the March 15, 2022 Commissioners' Meeting Minutes. The vote was called. The motion passed unanimously.

6. COG Update – Jenny Glass, Community and Economic Development Director, Oregon Cascades West Council of Governments.

Ms. Glass provided the Board with a COG Update. A copy of her report is on file in the Linn County Clerk's Office in the Commissioners' Staff File.

Ms. Glass updated the Board on the Transportation Mobility Hub and Albany Area Metropolitan Planning Organization (AAMPO). There was also discussion regarding wetlands. Ms. Glass also gave a brief update regarding the Bias Response Program.

A. Juvenile Update - Torri Lynn, Linn County Juvenile Department Director.

8. Treasurer's Office – Michelle Hawkins, Linn County Treasurer.

A. Order 2022-113 accepting an expenditure of a certain grant within the Health Fund, \$769,920.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve Order 2022-113. The vote was called. The motion passed unanimously.

9. Road Department - Wayne Mink, Linn County Roadmaster.

Mr. Mink provided background information for the following items:

A. Resolution 2022-094 delegating authority to Wayne E. Mink, Roadmaster, to purchase paving services on upper Calapooia Drive.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve Resolution 2022-094. The vote was called. The motion passed unanimously.

B. Resolution 2022-104 delegating authority to Wayne E. Mink, Roadmaster, to purchase paving services on Richardson Gap Road.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve Resolution 2022-104. The vote was called. The motion passed unanimously.

C. Resolution & Order 2022-110 accepting a Petition to Vacate a public road, Monroe Street (Public Road 3602-D).

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve Resolution & Order 2022-110. The vote was called. The motion passed unanimously.

D. Roadmaster's Report on the Petition to Vacate Monroe Street.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to accept the Roadmaster's Report. The vote was called. The motion passed unanimously.

E. Resolution & Order 2022-111 approving the vacation of a public road, Monroe Street (Public Road 3602-D).

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve Resolution & Order 2022-111. The vote was called. The motion passed unanimously.

10. Planning Department - Alyssa Boles, Planning Manager, Linn County Planning and Building Department.

A. Resolution & Order 2022-058 approving applications for a Plan Map Amendment and a Zone Map Amendment; approving an Aggregate Mining Permit and amending Resolution & Order 2020-166.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve Resolution & Order 2022-058. The vote was called. The motion passed unanimously.

B. Ordinance 2022-059 amending the Linn County Comprehensive Plan Map and Zoning Map and amending Ordinance 2020-167.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve Ordinance 2022-059. The vote was called. The motion passed unanimously.

C. Resolution & Order 2022-084 approving a Zoning Map Amendment application by Julie Moore to change the zoning map designation on a 0.35-acre property.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve Resolution & Order 2022-084. The vote was called. The motion passed unanimously.

D. Ordinance 2022-085 amending the Linn County Zoning Map.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve Ordinance 2022-085. The vote was called. The motion passed unanimously.

11. General Services - Russ Williams, Linn County General Services Director.

A. Resolution & Order 2022-112 approving a Contract between Trane U.S., Inc. and Linn County and delegating authority to execute originals.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve Resolution & Order 2022-112. The vote was called. The motion passed unanimously.
