

MINUTES OF THE REGULAR SESSION OF THE LINN COUNTY BOARD OF COMMISSIONERS TUESDAY MEETING LINN COUNTY COURTHOUSE – ROOM 200 JANUARY 11, 2022

The Linn County Board of Commissioners met for the regularly scheduled meeting on Tuesday, January 11, 2022.

Those present at various times for the matters as indicated below were: Michelle Duncan, Linn County Sheriff; Micah Smith, Linn County Undersheriff; Ric Lentz, Emergency Manager, Linn County Sheriff's Office; Alyssa Boles, Planning Manager, Linn County Planning and Building Department; Carol Gordon, Linn County Code Enforcement Officer; Wayne Mink, Linn County Roadmaster; Michelle Hawkins, Linn County Treasurer; Alex Paul, Linn County Communications Officer; Alysia Rodgers and Troy Shinn, Reporter for <u>Democrat-Herald</u>.

1, 2, 3. At 9:30 a.m. Chair Nyquist called the meeting to order. The flag salute and roll call followed. Commissioners Roger Nyquist, Chair, Will Tucker, Vice-Chair and Sherrie Sprenger were present, as well as, Darrin L. Lane, Linn County Administrative Officer and Heather Gravelle, Recorder for the Board of Commissioners.

4. Approval of Agenda.

Action – Commissioner Tucker moved and Commissioner Sprenger seconded the motion to approve the agenda. The vote was called. The motion passed unanimously.

5. Approval of the January 4, 2022 Commissioners' Meeting Minutes.

Next, Carol Gordon, Linn County Code Enforcement Officer, introduced herself to the Board and provided them with a brief update of the Linn County Code Enforcement Program.
