Resolution & Order 2022-013

The Linn County Board of Commissioners authorized the Sheriff's Office to receive Coronavirus State Fiscal Recovery Fund (CSFRF) monies, to include \$1,200,000 allocated to a "Fire Radio Improvement Project". The Intergovernmental Agreement before you is to solidify the work to be performed by the Sheriff's Office, on behalf of the Linn County Fire Chiefs. This agreement ensures the Fire Chiefs maintain oversight of their part of the project, and project expenses, through a formal agreement with the Sheriff's Office.

Resolution & Order 2022-069

The Linn County Board of Commissioners authorized the Sheriff's Office to publish a Request for Proposals related to Fleet Vehicle Maintenance Services. This was achieved by R&O 2021-324. Through that process, including evaluation of the received proposals, the Sheriff's Office issued an Intent to Award notification to all proposers, naming Crabtree Automotive.

The contract before you, identified as Resolution & Order 2022-069, is the contract between the Sheriff's Office and Crabtree Automotive, subsequent to the provisions of the RFP process.

Re:	Resolution & Order No. 2022-086; Animal Control IGA with City of Albany

The Linn County Sheriff's Office has primary responsibility to regulate dogs within Linn County (Oregon Revised Statutes ORS 609.010-609.110). This responsibility includes collecting revenues from the sale of licenses and the redemption of impounded dogs, operating patrols to impound dogs running at large, and operating an animal shelter. In the effort to further economy and efficiency, the Linn County Sheriff's Office and the City of Albany wish to cooperatively support the sharing of animal control duties within the city of Albany.

This Intergovernmental Agreement defines the specific duties to be performed by Linn County and the City of Albany related to animal control. The City of Albany will have primary responsibility for responding to dog complaints, picking up stray dogs, issuing citations/warnings, and so forth within the City of Albany. For performing these duties, Linn County agrees to compensate the City of Albany up to a maximum of \$5000 per year for equipment related to dog enforcement.

Financial Impact: Up to a maximum of \$5000 per year

Parks Grant Application Authorization R & O 2022-087

I am planning to apply for the grant this fiscal year; however, the project would not be completed until 2024. No General Fund funding will be used to complete the project.
- The Oregon Parks & Recreation Department has specifically requested a board order from the local government governing body stating that the applying agency has the authority to submit grant applications. This requirement is part of the grant application package.

Resolution & Order 2022-088:

Contract with EZLease for their off the shelf software. Pursuant to new GASB 87 Leasing Standard, this software will provide a way to maintain all County leases, provide ease of use across departments, and provide reporting to help us document compliance with the new standard.

Financial Impact: This contract is for 3-years at \$5,610 per year.

Staff Recommendation:

The group that examined the different vendors included Bill Palmer, plus members of the Health department (Diana, Terri, and Sarah). (Sheriff's dept declined to participate).

After considering 3 choices, the group recommends EZLease due to its ease of use, its short implementation, and it being the lowest cost.
