The Linn County Sheriff's Office has annual contract agreements with fire agencies in Linn County for our 9-1-1 Communications Center to provide telephone answering services, along with triaging of incoming calls for assistance, routing of the call and appropriate dispatching of proper units to the scene.

The contracts and Resolution & Orders brought before the Board are similar to last year's contracts, with updated contract dollar amounts and date ranges (encompassing fiscal year 2022-2023).





RO 2022-166 An Intergovernmental Agreement Between Benton and Linn County for Detention Services

RO 2022-166 is an intergovernmental agreement between Benton and Linn County which enables Benton County to place youth into the Linn Benton Juvenile Detention Center. Benton County will continue to contract four beds at the detention center at a daily rate of \$288.33 per bed, per day.

Contract amount \$420,968 to be paid in four equal installments of \$105,242
