This Memorandum of Understanding comes before the Board of Commissioners for approval, to authorize the Linn County Sheriff's Office to work closely with the Oregon Department of Transportation on a radio shelter building. This building is ODOT owned property, and being given to the Sheriff's Office for retrofitting, and then placed at Buck Mountain as part of the overall Fire Radio Improvement Project. ODOT is also agreeing to give credit to the Sheriff's Office and fire agencies equivalent to the costs of the improvements to make to the shelter, to offset future site lease costs at Buck Mountain.

Udell Engineering & Land Surveying Contract R&O 2022-276:

- Resolution and Order 2022-276 is for approval of a contract with Udell Engineering to provide design/engineering services for the proposed Sweet Home RV Waste Water Disposal Facility.

Oregon State Marine Board Maintenance Assistance Grant-R & O 2022-282:

- Resolution and Order 2022-282 is for approval of a Maintenance Assistance Grant (MAG) with the Oregon State Marine Board. The MAG will provide approximately \$65,000 per year for the next two years for to reimburse Linn County for marine/boat ramp related expenses.
- The MAG Program replaces the Marine Boards Maintenance assistance Program (MAP), which was an annual funding program. The MAG program should provide Linn County with more flexibility in how marine maintenance funding is used in the throughout the County Parks system.
