### **Resolution and Order No. 2022-380**

## **A Personal Services Agreement for Life Space Crisis Intervention (L.S.C.I.) Training Facilitation Between Kela Lynn and Linn County**

**Contract Amount - \$7,500.00**

RO 2022-380 is an agreement between Kela Lynn and Linn County in the amount of \$7,500.00 for each fiscal year through 2026-2027 (5 years total) for a total contract amount of \$37,500.00.

The funding for this contract comes from Federal Title 1D monies, which Greater Albany Public Schools (GAPS) receives as a result of the Linn Benton Juvenile Detention Center and Jackson Street Youth Shelter – Albany House, being located within their district. GAPS has agreed to pass this funding back to the Linn County Juvenile Department to support various services and one of those services is L.S.C.I. training (see R&O 2022-351/2022-379).

As part of 'Healthy Students Safe Schools' Federal grant awarded over 10 years ago, the group Linn Council chose L.S.C.I. as the primary training curriculum to train adults in Linn County on non-violent crisis response and LBLESD was the lead agency for this grant. At that time, Kela Lynn worked for LBLESD as a Family Support Specialist and was selected to become an L.S.C.I. instructor. There is a certification process which requires instructors to renew their affiliation and certification every three years, and Kela Lynn remains the only L.S.C.I. Certified Senior Trainer in the State of Oregon. The original 'Healthy Students, Safe Schools' Grant has since been completed but then the opportunity to fund L.S.C.I. became available using Title 1D funds through a contract with GAPS. GAPS utilized this training district-wide, which is why this contract with Kela Lynn was developed. As a result of this partnership, the Linn County Juvenile Department offers this course at no cost for professionals working in Linn County.
