Detention

Benton: 6 youth were held for 52 total of days of care, 1 females and 5 males.

Total Admissions to Detention = 7

Average Daily Population = 1.86 youth

Average Length of Stay = 7.43 days

Linn: 21 youth were held for 279 total of days of care, 11 females and 9 males.

Total Admissions to Detention = 21

Average Daily Population = 9.96 youth

Average Length of Stay = 13.29 days

Lincoln 5 youth were held for 87 total days of care, 1 females and 4 males

Total Admissions to Detention = 5

Average Daily Population = 3.11 youth

Average Length of Stay = 17.40 days

Probation

The Juvenile Department received 26 referrals during the month of February 2023.

Of the 26 referrals, 4 represent dependency, 6 status and 13 criminal.

There are currently 189 youth in the Probation Unit either on probation or pending court with 35 of those being assessed high-risk.

There are currently 67 youth under the Community Programs Unit serving on informal probation and the Intervention Specialist is currently serving 85 youth. 82 of those youth are from the community with no involvement with law enforcement.

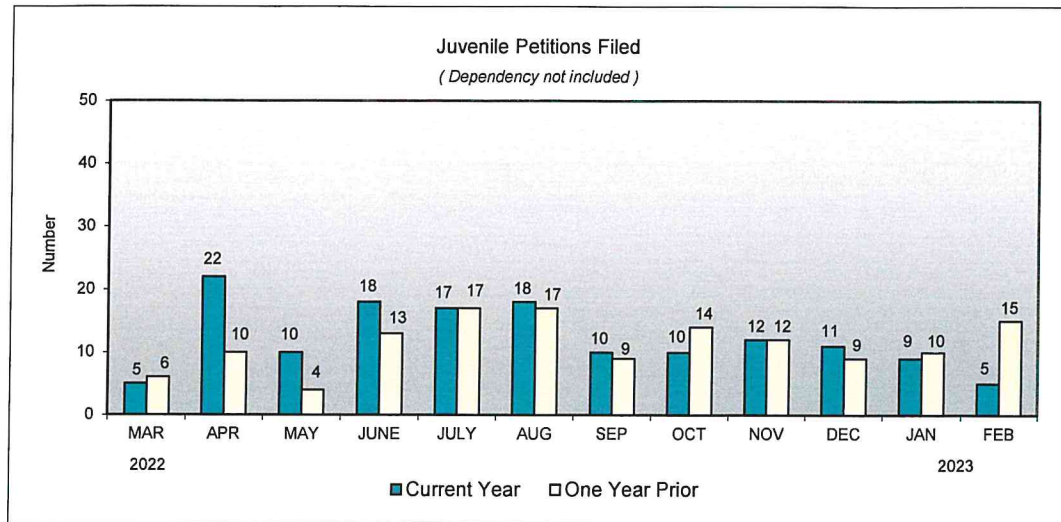

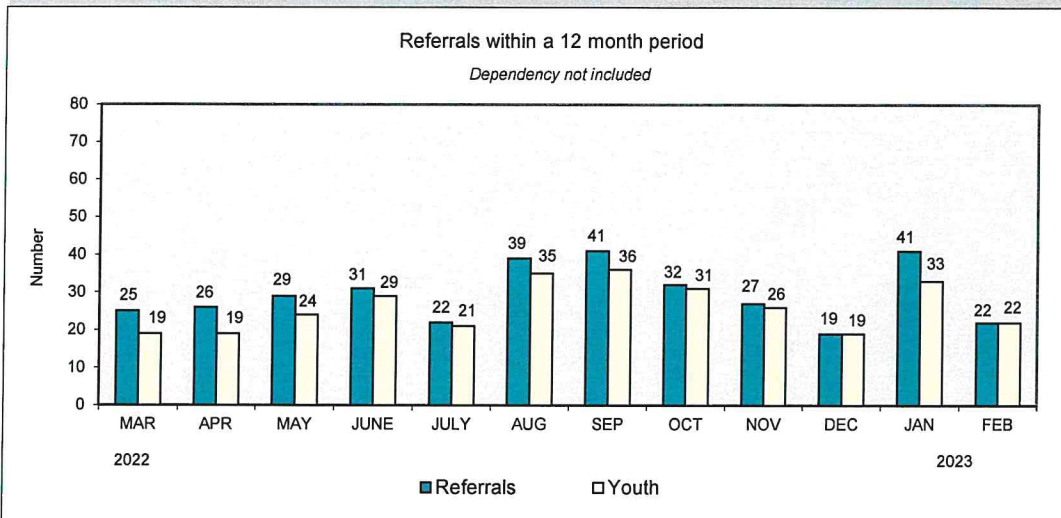

FEBRUARY 2023 Statistics**

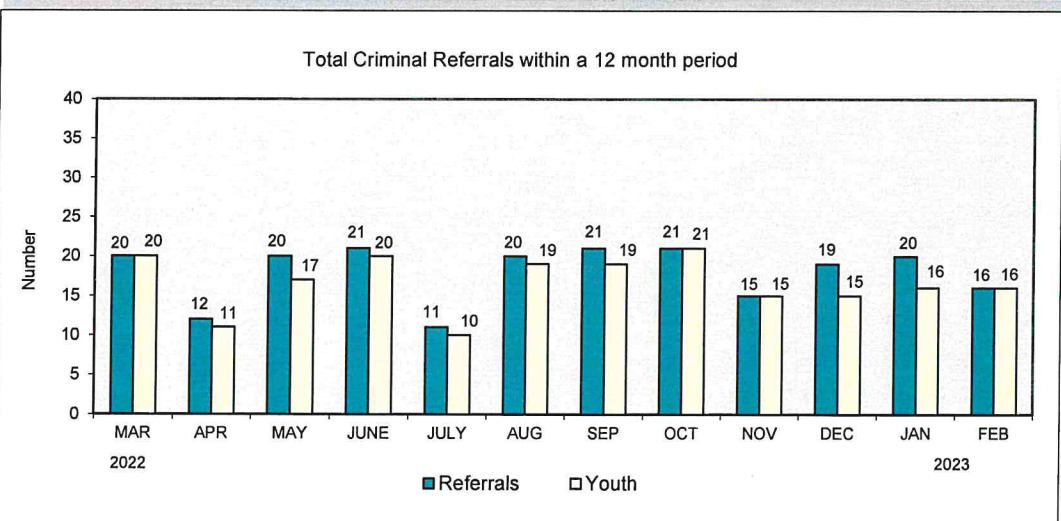

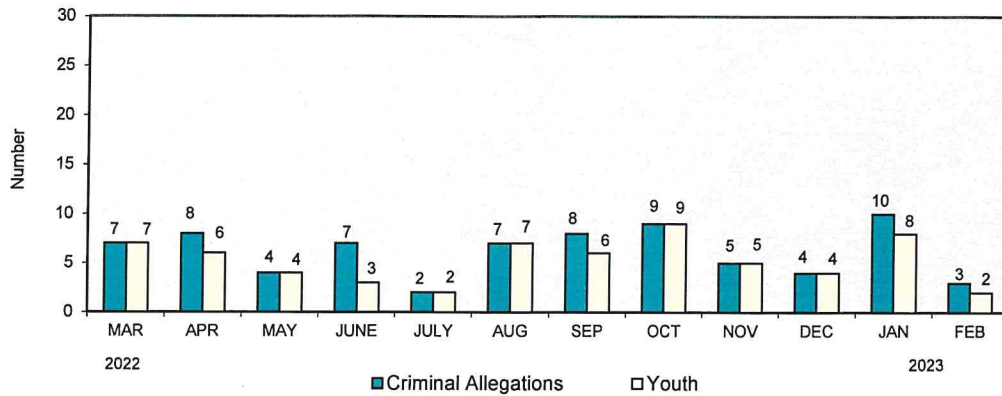

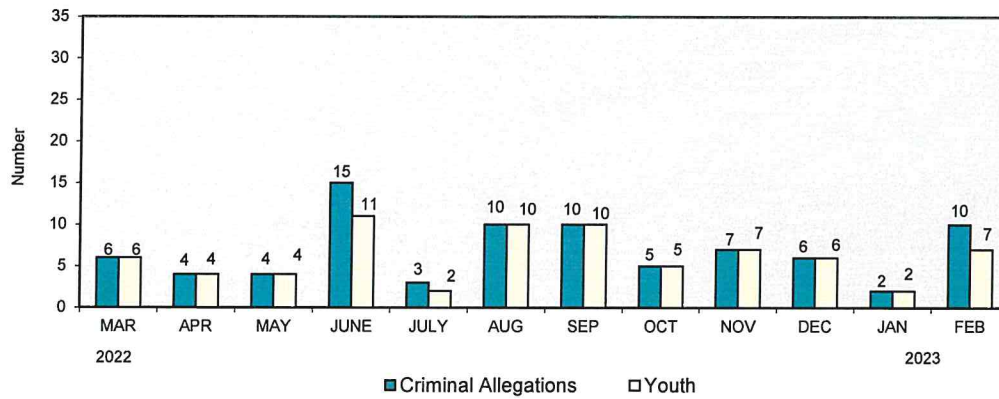

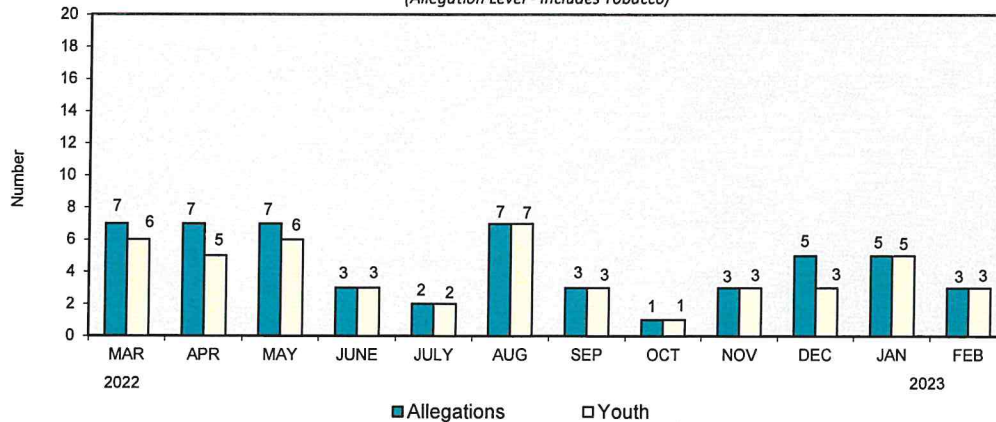
