Resolution and Order 2024-026

Amendment No. 2 to an Intergovernmental Agreement For the Youth Development Division Between the Oregon Department of Education and Linn County.

Bi-Annual Amount \$313,631

RO 2024-026 is an agreement with the Youth Development Division and Linn County to provide Juvenile Crime Prevention funding in the amount listed above. This bi-annual agreement in the form of the Juvenile Crime Prevention (JCP) dollars for the 2023-25 biennium. This money is being provided to Linn County by way of statute and through the Youth Development Oregon (YDO) to assist in the overall comprehensive juvenile crime prevention plan for Linn County. This money will be used to serve youth prior to being referred by a law enforcement agency to the Juvenile Department. It will be used to assist with the Linn Benton Lincoln Education Service District for the Family Support Program.

This funding passes through the Juvenile Department through a contract with LBLESD.

Vacation proceedings have been initiated by petition of 100% of the abutting landowners of a County Road, Wirth Rd (County Road 416) in Linn County, Oregon.

As Linn County Roadmaster, I am providing this report as required by ORS 368.346(1), and requested by the Linn County Board of Commissioners.

A map showing the property proposed to be vacated and the ownership of the properties abutting or underlying that portion of the right-of-way proposed to be vacated is attached for your review.


One Hundred Percent (100%) of the owners request vacation of the roadway.

I find that no owner of a recorded property will lose the right of access by this proposed vacation; and further, that the property is not needed for use as a county road to provide access to parcels of other ownership abutting or underlying the roadway to be vacated.

Therefore, it is my opinion that it is in the public interest that the vacated property shall vest in the owners of land abutting the vacated property as shown on the attached map [pursuant to ORS 368.366(2)].

The following item(s) are scheduled to be heard on January 9, 2024:

Resolution & Order 2024-014: Linn County Parks and Recreation proposes to update our fee schedule now, rather than on July 1 to provide greater consistency for our guests during peak summer camping season. These changes will have no effect on previously booked reservations.

<u>Financial Impact</u>: LCPR is self-funded through camping fees and facility rentals. In order to continue this model, fees have to keep up with increasing costs. Cabins and yurts are staff intensive as they require more cleaning between uses. After evaluating usage patterns for LCPR facilities, we opted to incentivize use of lesser used facilities by not increasing fees at those locations. Additionally, there are several things we are hoping to add to our options in the next year or two- glamping style wall tents and pontoon boat rentals. Adding these options will help to diversify the offerings we are able to provide to the public.
