As part of our ongoing project improving the VHF Fire Radio System for all Linn County fire agencies, this agreement comes before you today for a new radio repeater site at Peterson Butte, outside of Lebanon. The site is owned and operated by Consumers Power, Inc who have proven to be a great partner, working with us to make this vital and central site in the populated areas of the county a part of our project.

The lease for this site is held by the Sheriff's Office, and the fees are paid for through a number of sources, including the fire agencies through annual billing, and the Emergency Telephone Agency 911 tax collections (which can only be spent on a very narrow list of items).

#### R&O 2024-033 Linn County Title/IV Program Summary:

In order to receive State and Federal transportation funding, Linn County is required to have a Title VI Program on file with ODOT and update this plan every three years. The Title VI Program describes Linn County: population of speakers of languages other than English, identifies efforts and procedures to mitigate discrimination, and includes a public participation plan for transportation.

The Linn County Title VI Program has been through an extensive editing process and has been reviewed by ODOT for compliance. ODOT requires the Title VI Program be approved/adopted by the governing body. Once the Linn County Title VI Program is approved by the Board of Commissioners, the updated version will be submitted to ODOT and replace past versions on the Linn County website.

#### Recommendation:

It is respectfully requested that the Board of Commissioners adopt the Linn County Title VI Program.

#### R&O 2024-037 5311 COVID Relief funds ODOT Agreement 35641:

During the COVID pandemic, special relief funds to support Public Transportation Service Providers have been disbursed from Federal resources. This was established to assist providers in maintaining services through a long period of reduced ridership and to increase staff/driver retention allowing for hazard pay in the public facing positions.

ODOT announced the end of COVID Relief Funding with a final opportunity to apply and exhaust the remainder of the resource. Linn County assisted Senior Citizens of Sweet Home in applying for operating assistance. The Linn County/ Senior Citizens of Sweet Home, Inc. application was selected to receive a portion of the remaining funds and because the application scored high, were awarded above the value in the application request.

R&O 2024-037 requests entering into Agreement 35641 allowing Linn County to receive Federal 5311 funds and fulfill the role as QE, bridging the gap between funding opportunities and the transportation provider in need.

### **Board Summaries for February 6, 2024**

#### R&O 2024-028

This is an Intergovernmental Agreement between the Oregon Health Authority and Linn County to provide financing for Community Mental Health, Addiction Treatment, Recovery, Prevention, and Problem Gambling Services. This agreement is in effect from January 1, 2023 to June 30, 2025.

#### R&O 2024-036

This is a new Job Classification for the role of Fiscal Grant Manager. Given the heightened criteria set forth by both Federal and State funding sources, this position is crucial for ensuring adherence to regulatory standards.

#### R&O 2024-043

This is a revision to the current Developmental Disability Program Manager Job Classification to align with the lates requirements for this position.

#### **REFUND REQUEST**

This refund request amounts to \$122,179.34 and pertains to the 21-23 Justice Re-Investment (JRI) grant administered by the Criminal Justice Commission (CJC). The grant initially allocated funds to sustain a 1.0 Full-Time Equivalent (FTE) position for the Yellow Line Program and engage contracted peer support services through CHANCE. However, due to staffing shortages, personnel designated for this grant were redeployed to fulfill other responsibilities, such as crisis services. Towards the conclusion of the grant period, JRI granted permission for the reallocation of funds to procure curriculum, computers, and vehicles in support of the grant's target population. The remaining balance reflects the funds not utilized for the specified purchases after the reallocation process.
