Shall the District impose \$0.81 per \$1,000 of assessed value for general operations for five years beginning in 2024-2025? This measure may cause property taxes to increase more than three percent.

Jefferson Rural Fire Protection District's current local option levy of \$0.38 per \$1,000 of assessed value explres June 30, 2024. This measure replaces the current levy with a new five-year levy at the rate of \$0.81 per \$1,000 of assessed value. The new levy would start July 1, 2024, after the current levy expires.	
If adopted, the District would use tax revenue to cover increased operating costs, replace an aging ambulance, add three full-time Paramedic/Firefighters to increase staffing levels to meet the growing demands on District services caused by increasing emergency call volume.	
If the levy fails it will cause a budget shortfall for operations, reduce recruitment and retention of volunteers, reduction in staffing capabilities, elimination of water rescue, and the ability to maintain apparatus and facilities.	
Homeowners with an assessed property valuation of \$300,000 would pay \$243.00 in property taxes per year or \$20.25 per month.	
The measure would raise approximately \$693,135 in 2024-25, \$713,929 in 2025-26, \$735,347 in 2026-27, \$757,359 in 2027-28, and \$780,130 in 2028-29, for a total of \$3,679,900.
