ESSENTIAL FUNCTIONS OF THE JOB: Perform the following essential functions and related duties:

- Perform engineering work in the planning, design, construction, project management and maintenance of public works and related projects; such as, bridge and road design and construction, traffic design, drainage facilities or other transportation related functions
- Participate in design, preparation of project plans, specifications, and cost estimates for public works projects
- Prepare progress reports, field notes, engineering studies and maintain records
- Provides quality assurance in reviewing construction submittals, schedules, and other documents
- Coordinate assigned activities with consultants, engineers, contractors and other outside agencies
- Plan and perform inspections
- Review and evaluate project compliance with applicable local, state and federal laws and regulations
- Assist with right-of-way duties, including cooperation and coordination with utilities
- Other duties as assigned

QUALIFICATIONS:

- Equivalent to a Bachelor's Degree from an ABET accredited college or university with major coursework in civil engineering, construction engineering management, or related field, or any satisfactory equivalent combination of experience, education and training
- Possess an Engineer in Training (EIT) Certificate from the State of Oregon, or obtain one within 1 year of hire
- Minimum (1) year of design or project management experience delivering public works capital improvement projects or other construction related projects
- Ability to read and understand program manuals, technical drawings, technical reports, engineering plans, specifications, and contract documents
- Proficient using Windows operating systems and Microsoft Office (Excel, PowerPoint, Word, Outlook)
- Possession of a valid Oregon Motor Vehicle Operator's License and an acceptable driving record
- Will lift fifty pounds and work in all types of weather
